Following the Pledge of Allegiance, Mayor Amsden called the meeting to order. Councilperson Turnbough moved to approve minutes of previous meeting as submitted by Clerk Fruit. Councilperson Morris seconded the motion, motion carried.

Mayor and Council reviewed the following: Letter about wastewater project update from Interstate Engineering; MKK Consulting Engineers, Inc. now IMEG standard hourly rates and proposal for electrical engineering services for the Broadus Lift Station project; Dorsey & Whitney LLP letter regarding Sewer System Revenue Bond for the Broadus Lift Station Project; Uniform Application Form for Montana Public Facility projects. Clerk Fruit discussed with the Mayor and Council the Tongue River Electric Cooperative work order to move the power for the Broadus Lift Station project. The Town of Broadus has signed a Coal Board Contract with award of \$200,000 which will go towards the project. Once the finalization of the contract is done, Clerk Fruit will pay the engineering invoices that have been on hold. Remainder of the project will be funded by loan; Town of Broadus is currently working with SRF to secure the funding. The Broadus Sewer Project will begin to bring the Town in compliance with Department of Environmental Qualities; plus get rid of the hazard of a confined space. Department of Environmental Quality must sign off on the project prior to the beginning of the project. Will need to define the sage grouse habitat as one of the requirements. Public hearings will be held once the cost of the project have been clearly defined and the amount of rate increase of the sewer portion of the utility billing will be discussed. This project will begin moving rapidly over the next few months.

Public Works Ragsdale reported the recent flooding filled the sewer mains which resulted in the water to come up in some residents' basements. Clerk Fruit has submitted those claims to MMIA for processing. Public Works Zimmer reported on the street damage and the areas involved; silting in the park and has meet with Jeff Gates, Montana Disaster and Emergency Services on how to proceed. Emergency Resolutions have been done to declare the Disaster and Emergency Mill levy of 2 mills will need to be done to qualify for the disaster money if any is made available.

Denny, Downey, & Associates has been contracted for the State requested Financial Review of the Town of Broadus for 2017-2018. Clerk Fruit will work with them to complete the process.

Clerk Fruit discussed the health insurance through MMIA and the increase seemed very reasonable and the Mayor and Council agreed to the new rates.

Bev Miller addressed a residence in Broadus; weeds extremely tall, tree branches that need cut, worried about the fire concerns. Clerk Fruit will contact the resident by letter to inform them of ordinance violations.

Public Works Ragsdale updated the Mayor and Council of the probable cost of the lagoon project came in at \$1,011,000.00. Working with Department of Environmental Quality, they have 14 areas of concern on the project which need to be defined. Discussed the prefabricated lift station with pumps which would be installed above ground deleting the confined space. Clerk Fruit shared the rate comparison from DNRC to show the water and sewer rates from around the state for the years of 2013, 2015, and 2017. The sewer rate would have to be raised in order to pay for the project, the projected increase is between 10 to 15 dollars. This amount will be more defined after several other parts of the project are completed. There is a possibility of some loan forgiveness on the project that might affect the rate increase. Nothing is final as of yet, public hearings on the rates will be held at a later date.

TRECO submitted the cost of changing location of the power to the lagoon. This cost is included in the proposed cost to the project.

Public Works Zimmer reported on patching and working on the park; will place additional dumpsters around the town during the 4th of July activities. Also working with FEMA on the recent flooding to secure money for the costs of the repairs. Clerk Fruit reported to qualify for the program 2 emergency mills will be budgeted for to cover part of the Towns obligation for the repairs. The amount of the 2 mills will be approximately \$800.00 total.

Clerk Fruit reported the possible changes for the Fire Department work comp rates. Councilperson Wenzel requested the be looked into, our fire fighters are worth the extra cost. All agreed.

Would like the Mayor and Council to consider a policy or ordinance regulating the overnight parking around the town square during the winter months. When snow is on the ground it works better not having vehicles in the way with early morning plowing. Been having calls about campers parked on town right of way whether lived in or not. This also needs to be addressed by Council.

Lowell Cutshaw discussed with Council the engineering contract amendment to include O&M manual and 11th month walk through of the project as suggested by DEQ. Councilperson Morris requested further information needed before a decision could be made. The amount of the amendment is higher than Council feels it should be. Will visit with DEQ during the project conference call on November 13th.
